MEETING CALLED TO ORDER: 19:01

The meeting was called to order by President Scott Kellar at 19:01 hours.

INTRODUCTIONS:

President Kellar welcomed everyone to the meeting.

APPROVAL OF THE AGENDA:

President Kellar called for any additions or suggested changes to the agenda and there were none.

Director Lehman seconded the motion, which passed unanimously.

DEPARTMENT/OFFICERS' REPORTS:

District Updates – Fire Marshal

The fire marshal services activity report for November 1 – November 14 includes a will serve letter for detached garage on Shoshone, existing building inspections for Parmalee Elementary, Saunders & Johnson HVAC, and Eudaimonia. Chief Forgy stated that we will be seeing more on the fire marshal activity report as the yearly fire inspections are completed. The invoice for these services will be placed in line for payment.

Chief's Report

Chief — Mark Forgy

Chief Mark Forgy reported that we purchased the new laptops for the ambulances, half-funded by the EMTS grant and we are still working on installing the off-line software. He informed the board that Geneva Glen is confirmed for the Awards Banquet on January 20 and we are working on bids for food. He then gave an update on the Community Paramedics program, giving kudos to Suzannah Epperson for taking the lead and recognition of her enthusiasm to help the elders in the community. The calls for November are as follows: 2-Medicals, 2- MVAs, 1- Cancelled Enroute, 2-Lift Assist, 1-Good intent.

A total of 8 calls for October and 169 calls for 2023 to date.

Officers' Reports

Assistant Chief — Marc Rosenberg

Director Rosenberg reported that he will be out most of December.

Fire Captain — Mike Fassula

Fire Captain, Mike Fassula, congratulated Joe Mellberg and Sean Houghton for passing FFI. He reported that we have six new members this year and training is going great.

EMS Captain — Pat Sears

Nothing to report.

OLD BUSINESS:

EMTS Grant Status

The ambulances' new laptops were previously covered in the chief's report. Chief Forgy added he hopes the e-bikes are completed and ready for pick up soon.

NEW BUSINESS:

Statewide Evacuation and Clearance Time Modeling

The state passed to evaluate vendors to model evacuation for WUI counties.

Proposition HH Outcomes

President Kellar reviewed the new procedural requirements for the budget process if Proposition HH is successful, providing a short time to assess impacts for the 2024 budget year. Proposition HH will provide a short-term relief to taxpayers and will reduce the evaluations of property tax only.

Property Tax Relief Legislation

President Kellar reviewed with the board the SDA Property Tax Survey stating the district is not planning to certify less than the highest mill levy with a temporary credit in PTY2023, yet instead

certify the current mill levy rate as the district is small and large capital expenses or fire apparatus replacement costs require building the reserve funds to execute those expenditures when needed.
